



Egypt Pre-Shipment Inspection Program for Food Products

To strengthen Egypt's food control system, the National Food Safety Authority (NFSA) implemented the PSI (Pre-Shipment Inspection) scheme to regulate food products import in the country and safeguard the well-being of the Egyptian consumer. Further, this scheme is also aimed at helping traders, exporters and importers to gain a smoother customs clearance process.

Commencing from 1st December 2020, the program applies to imported food and food contact products, which are subject to conformity assessment in accordance to decree no. 2020/2 & decree no. 2020/14.

Overall, the conformity assessment of imported food products requires controls such as sampling, testing, inspection, loading supervision and container sealing.

As the appointed inspection body, TÜV Rheinland is officially authorized to issue the Certificate of Inspection (COI) in accordance to the latest NFSA PSI requirements.

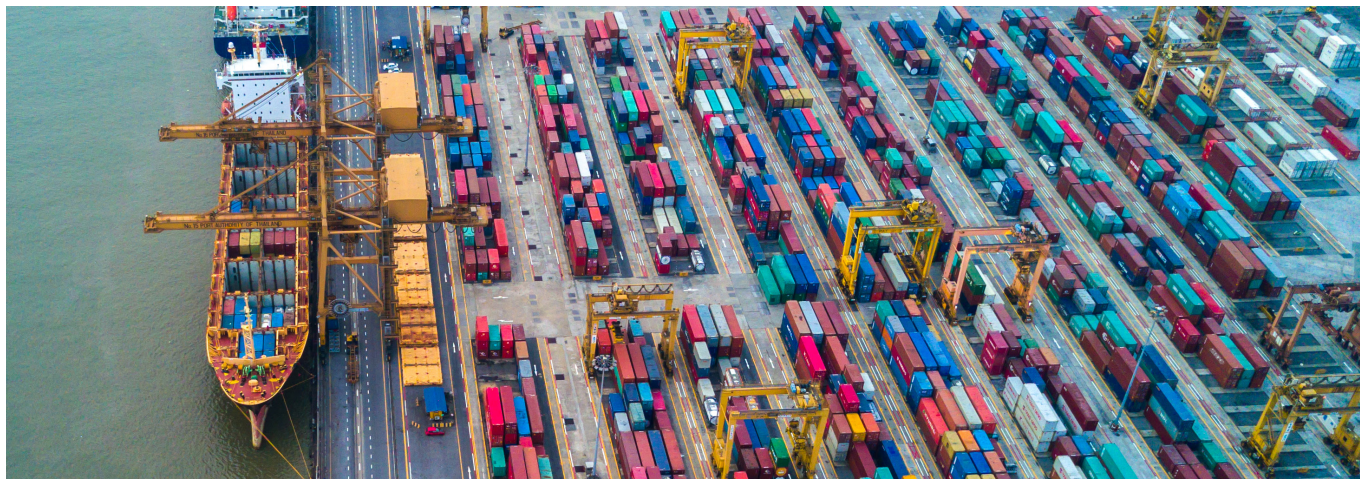

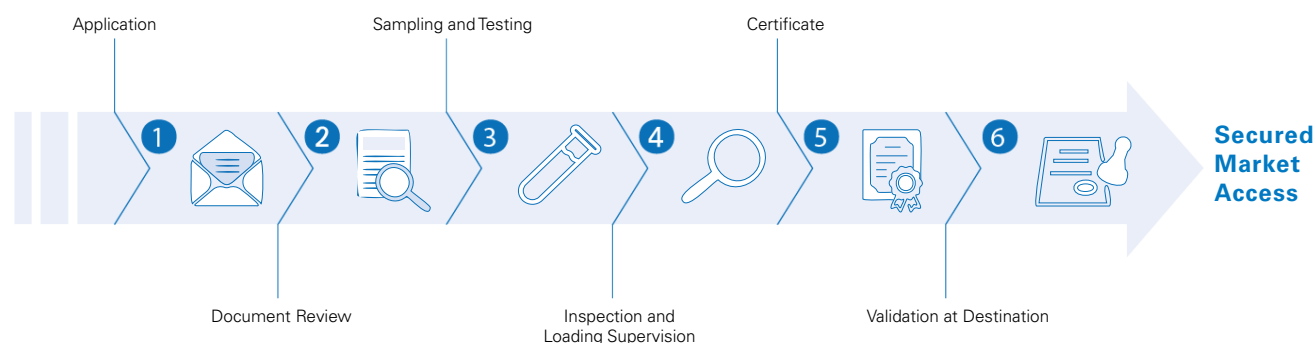

1	From 0 to 60,000	600
2	From 60,000 to 100,000	800
3	From 100,001 to 200,000	1,500
4	From 200,001 to 500,000	2,500
5	Above 500,001	3,500

- TÜV Rheinland application form signed and duly filled
- Test report for applicable products
- Pro-forma invoice
- Packing list
